3.1 Chairperson

• The 2nd meeting of the Student Council was held on April 21st 2021. The council discussed and voted on a recommendation for Student Care health insurance packages.



- In-person Final Exams Committee have administered a survey to the student body concerning feedback on the proposed in-person final exams that the College is preparing. A total of 3,456 students responded to the survey and shared various concerns about the situation.
- The Committee is continuing to consult students and are in the process of preparing formal letters and press releases in the event that the ongoing situation escalates. The Director of External Affairs is in contact with French and English student associations in the network regarding the final exams scenarios at other colleges.
- The General Assembly reports are being prepared and must be finalized prior to the upcoming week.

3.2 Treasurer

- The new constitution final draft is being prepared for the General Assembly to be presented to the membership for ratification. The Chairperson and Treasurer will continue to finalize the drafts with the union's legal counsel.
- The accounting firm is preparing the official statements for the General Assembly. However, in the event that the final documents aren't ready to be delivered to the membership, the current financial statement drafts are up to date.
- Held a meeting with a student group concerning their application for Special Project Funding.
